In addition to senior DOE staff we met with Community leaders from TRIDEC, City of Richland, Tri-Cities Visitor & Convention Bureau, CREHST, the Reach, the Hanford Communities Organization, and several other individual supporters of B Reactor and the proposed Manhattan Project National Historical Park. Working with and gaining the support of local and regional organizations is essential as we work together on our mutual goals. Cindy serves as a great catalyst in this regard.

As we look forward to 2011 we will need to continue working on all fronts toward making B Reactor an even more impressive museum. We will collaborate with DOE, its mission support contractor (MSA), and others on a number of efforts. This will include, but not be limited to, increasing the number of tours, improvements on tour content, helping identify and portray artifacts, enhancing and/or having more displays, and updating the vignettes.

Progress Toward Manhattan Project NHP

Greetings from Washington, DC! It was a great pleasure to meet with the B Reactor Museum Association at its December meeting. I enjoyed my trip to Hanford and the chance to see firsthand the many recent improvements at the B Reactor Museum.

The following is an update on the progress towards a Manhattan Project National Historical Park. As you know, Congress passed legislation in 2004 directing the National Park Service to study whether it was suitable and feasible. After six years, NPS issued a draft study in January 2010 finding that it was not "feasible" to include the facilities at Hanford and Oak Ridge. Thanks to BMRA's letter of Jan. 22, 2010, and vigorous statements from the Hanford community and political leaders, we understand that final recommendations will include both Oak Ridge and Hanford.

Assistant Secretary Ines Triay deserves tremendous thanks for her leadership at the Department of Energy. She was instrumental in facilitating an agreement by DOE to own and maintain its Manhattan Project facilities in perpetuity. Based on this, the Department of Interior has agreed to include all three sites as units of a Manhattan Project National Historical Park.

We expect that the Departments of Interior and Energy will jointly recommend a three-unit Manhattan Project National Historical Park to Congress in January 2011. Then it will be up to the 112th Congress to designate the park. We are very fortunate to have Congressman Doc Hastings in line to be the Chairman of the Natural Resources Committee and Senator Jeff Bingaman remaining as Chairman of the Energy and Natural Resources. Senators Murray and Cantwell have long been behind a national historical park for the Manhattan Project sites. Overall, the Manhattan Project delegation bring very strong bipartisan support for the legislation.

We will be working with Cindy Kelly on the potential development of a table scale-model of the complete B Reactor complex depicting the vast complex of support and infrastructure facilities as they existed when B was in full operation. This model will be helpful for tourists to better comprehend and understand the full complement of activity at B during operation. It will also help them understand the tremendous engineering and construction effort put forth in such a short time to get B on line during World War II. We will continue to assist Cindy with the items she identified in her article elsewhere in this issue.

Of course our major effort during 2011 will be to continue working aggressively on the establishment of the Manhattan Project National Historical Park. BRMA encourages all its members---especially those not living in Washington State---to request members of their Congressional delegation to support the proposed Park. When Congress formally receives the study, BRMA plans on notifying all members and encouraging them along with their family and friends to mail or otherwise forward support requests.

In late December 2010, the Crystal Trust of Wilmington, DE, awarded the Atomic Heritage Foundation a grant towards the publication of a new book, "A Guide to the Manhattan Project Sites in Washington." We have already created a guide for the Manhattan Project sites in New Mexico and have plans to create ones for both Tennessee and Washington as part of a series. The books are filled with first-hand accounts and full-color photographs to help students and visitors learn about the Manhattan Project and the places and buildings associated with it. On December 15, Burt Pierard, Maynard Plahuta, and Tom Marceau met with me to brainstorm what should

be featured in a guidebook for Hanford. We look forward to working closely with them and other BRMA members as we draft the guidebook this winter.

The Atomic Heritage Foundation is also working on a national traveling exhibition to complement the future Manhattan Project National Historical Park. A planned first step is to convene a series of workshops at the

three Manhattan Project sites with leading museum designers, scientists, historians and veterans as well as representatives of the National Park Service, Department of Energy, and its laboratories. Our vision is for a compelling interdisciplinary exhibition on the Manhattan Project that would be welcome in both science centers and history museums. The exhibition would combine the history as well as what the Manhattan Project's legacy is for the 21st century, from nuclear weapons and nuclear energy to a vast array of innovations in science and technology.

The support of the Tri-Cities and surrounding communities continues to be essential as we work together towards these important goals. We will keep you posted in what will certainly be an eventful New Year,

Treasurer's Report

The calendar year 2010 was a moderate one with respect to our income and expenses. BRMA provided a fewer number of the B Reactor tour guides than in 2009, resulting in a smaller amount of gain from payment for those tours. BRMA was paid a total of \$8,745 for tour service. Of that amount a total of \$3,075 was "donated" to BRMA by our guides. Other sources of income were

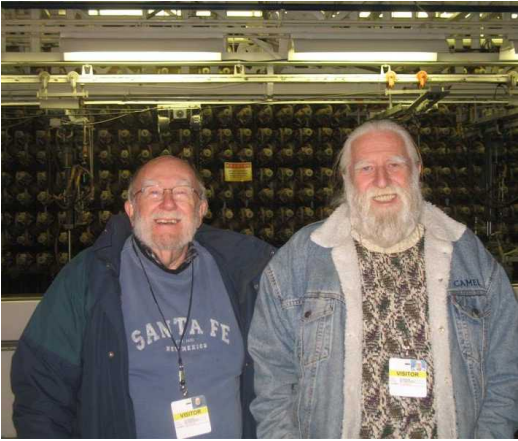
member dues, donations, and investment income. Two major expense items were the replica National Historical Landmark plaque and storage space rental.

Overall income for the year was \$11,196 and our total expenses were \$7,215; for a positive cash flow of \$3,981.

Cindy came to town on Monday, Dec. 13, and joined our regular BRMA meeting that night (see Cindy's article elsewhere in this issue). On Tuesday, she went to B Reactor with Maynard to join up with our BRMA group coming from an inspection of the White Bluffs Bank Building. After a brief tour and inspection of the pile of surplus graphite pieces (which we are proposing to use for a full-size mock-up model), we sat down to a sack lunch and discussed several proposals. One of the ideas was to seek out the construction of an architect's scale model of the whole original 100-B Area.

On Wednesday, Cindy spent the day in meetings with other principals in discussions of various aspects of the upcoming National Historical Park. One of these discussions was on BRMA's contribution to the Hanford Engineering Works Guide Book for the Park (see article on the Guide Book elsewhere in this issue).

BRMA Takes Lead On HEW Guide Book Research

Cindy Kelly, American Heritage Foundation President, has asked BRMA to take the lead on research for the Hanford Engineering Works Guidebook for the Manhattan Project National Historical Park.

Cindy plans to have a separate Guide Book for each of the three principal locations (Los Alamos, Hanford and Oak Ridge) and has already drafted up the Los Alamos version. BRMA has suggested that the three books be exclusively site specific (no inclusion of pictures, etc. from the other sites) and then roll all three, as sections, into a Master Book. The Master Book would include sections for other facilities such as the Chicago Met Lab.

Early research on this project has already unearthed an interesting story line that I don't believe is covered in any of the history books, at least none of

the books I've seen. Namely, what were the initial facilities used to get the Hanford Project off the ground, so to speak?

Not to get bogged down in the chaotic details, after a DuPont man arrived on Feb. 25, 1943, (with many DuPont and Corps of Engineers people following close behind) to determine available (leasable) space in Pasco, suffice it to say that DuPont leased the 3-story A. P. Gray Building at 4th & Lewis on March 1, 1943, as its Temporary Construction Headquarters. The Project officially opened for construction on March 22, 1943, coincident with the opening of DuPont's Employment Office in the Gray Building.

You'll have to read the book to get the story of the Pasco Housing Department (May 1, 1943 – also in the Gray Building).

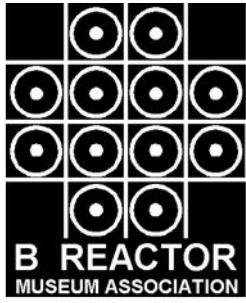
